Acknowledgement and Authorization

Students will receive a 100% refund (less a \$10 processing fee) if they drop prior to the first-class day; they will receive an 80% refund (less \$10) if they drop before the second class. Courses that lack sufficient enrollment will be canceled by 12:00 noon, two business days prior to the first-class day. Students will only be contacted if a course is canceled or if any changes are made to the course information originally published in the CE schedule.
